City Council Considers Street Plan. Each year, City administrators provide the City Council with an update regarding funds available to undertake street reconstruction and rehabilitation projects over the next five to six years. That plan was outlined at the December 9 City Council meeting. The first reading of the resolution approving the plan took place on December 23 with final action to be considered on January 13. The plan calls for reconstruction of Independence Boulevard, E. Harris Street, the Hall/Washington/McClure route, and two blocks of W. Harris Street over the next five years. Pension Funding To Be Discussed. In early 2019, the City was notified by the Michigan Department of Treasury that its pension funding did not comply with a new state statute. In response, City Council approved a corrective action plan. That plan was accepted by Treasury in mid-December with the requirement that action to implement the plan must be taken within the first six months of 2020. The plan requires Council to consider additional funding sources such as millage requests or public safety special assessments to generate addition monies for pensions.
