December 2022 Monthly Report

Monthly Statistics:

- See attached report.

Training:

- Officer Slaughter attended regional AVI (Active Violence Incident) training in Lansing. This training is now mandatory for all officers to have through MCOLES (Michigan Commission on Law Enforcement Standards). All CPD officers have now completed this training.
- Chief Brentar instructed at the regional AVI training in Lansing.
- Officer Fullerton began his online training to become certified as a Property/Evidence officer.
- Officer McDaniel assisted with instructing at the AVI training in Lansing.
- All officers completed 4 courses of NIMS (National Incident Management System) training online.

Operational Highlights:

- On 12-03 a traffic stop was made and the driver was arrested for carrying a concealed weapon (pistol). The pistol and loaded magazines were seized during this traffic stop.
- On 12-09 Recruit Leach graduated from 110th Mid-Michigan Police Academy at Lansing Community College. Officer Leach is now in the FTO (Field Training Officer) program which is 16 weeks long where he is trained by our Field Training Officers.
- On 12-06 officers transported a suspect from the Calhoun County Jail to the Eaton County Jail on 3 different warrants out of Charlotte, including one felony for dangerous drugs.
- On 12-07 officers were called to a suspicious vehicle at 1716 Lansing Rd. Upon arrival a female took off running but was apprehended. She was cited for minor in possession and was also a runaway from the sheriff's office.
- On 12-09 officers assisted the sheriff's office in locating a stolen vehicle at 305 Warren Ave.
- On 12-13 officers assisted Code Enforcement with the removal of tenants at 417 S Sheldon St due to it being condemned.
- On 12-14 an officer made a traffic stop on a vehicle where the driver had outstanding warrants for his arrest. The driver fled on foot. A K9 was called to track but was not able to locate the driver. Additional charges are being sought.
- On 12-15 an officer assisted parole with attempting to locate a subject that cut off his GPS tether.
- On 12-17 officer were called back to 417 S Sheldon for a subject who went back into the building and refused to leave. The subject was arrested for Illegal Entry.

- On 12-18 an officer observed a subject at Speedway who had an outstanding felony warrant out of CPD. The officer made contact with the subject where 9 grams of Methamphetamine were located with a street value of approximately \$2100, along with other drug paraphernalia, and an illegal knife. The subject was lodged and additional charges have been requested.
- On 12-12 Det. Poortvliet traveled to Marquette to interview a suspect who used to live in Charlotte on Criminal Sexual Conduct allegations involving multiple victims. These allegations were just disclosed to Det. Poortvliet the week prior and occurred here in Charlotte just over 2 years ago. Det. Poortvliet was able to obtain a confession from this suspect who was arrested and transported back to the Eaton County Jail (part way by Marquette Co. Sheriff and then CPD). He has been charged with 3 counts of CSC 1st degree/person under 13, and is awaiting trial.
- During the recent snow storm over Christmas, officers handled 48 calls for service.
- On 12-29 our new patrol vehicle that was ordered in July was put into service.

Outreach/Public Events:

- Sgt. Antcliff, Officer Carroll, & Officer Homrocky collected non-perishable food at Walmart on 12-03-22 as part of the Fill-A-Cop-Car event to benefit local food banks. The East Side Food pantry, located at Beacons Sales, was stocked up and the rest was brought to Helping Hands here in Charlotte. Over 4400 pounds of food was collected.
- Chief Brentar, Sgt. Brown, & Officer Callahan participated in the annual Shop with a Hero program on 12-20-22. Officers enjoyed a meal with the kids at the Senior Center followed by shopping at Meijer. The officer's union, Maple City Lodge 178, generously donates to this program each year to help provide a full holiday meal to all of the kid's families.
